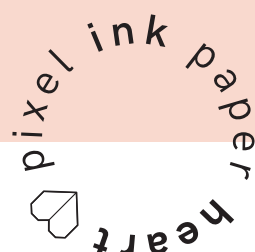
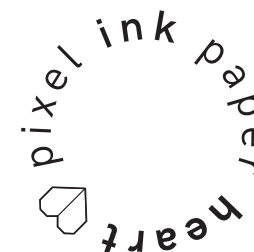




Terms + Conditions



Acceptance

Pricing

Quotes are valid for 30 days. Pricing may change due to scope of work changing. Client will be notified as soon as possible about price change should there be any variance from the original quote.

Design Payment

Any new projects will require a 50% deposit before any work is undertaken. Full payment is expected upon completion of work. Any invoice that remains unpaid after 7 days from date of invoice will incur a late fee of 5%, for every month that it remains unpaid. All overdue accounts forwarded to a collection agency will incur further collection charges.

Design Delivery

The delivery times of each project will be communicated to you upon you supplying all required elements for the project to commence. Should you have a must meet deadline please communicate this as soon as possible. Design can happen as quick as 1 day if you have a clear idea of your direction. On average design is a 7 day turn around, however branding is a more in depth process and you could expect you completed files within 21 days if all goes to plan.

Printing Payment

All print projects require 100% payment before projects will be sent to print. Due to the nature of custom printing, payment is required up front as the printing is of no use to any other person other than the intended.

Print Delivery

The delivery times will be communicated to you upon final artwork approval and payment. Specialised print finishing often takes longer. An estimation of delivery for your order is made from the information available to us at the time. Circumstances beyond our control may change this date. Pixel Ink Paper Heart will not be held liable for any jobs that are delayed. Should have a must meet deadline please communicate this before print. Standard type printing can be ordered and delivered wias early as 2 days from payment. On average printing is a 7 day turn around. However, specialised finishes are rarely available for dispatch earlier than 21 days.

Final Proofing and Approvals

This step is the most important on your behalf. While every care is taken when producing your artwork, typographical errors may still occur. Therefore, I request that you take the time to double check all the information on your design. Please read through your design carefully before approving, as errors and/or omissions become your responsibility upon approval of artwork. Once you approve the design and I send the artwork to print, changes cannot be made without the printer invoicing me for another print run. Any changes required after print approval will be treated as an additional print order.

Print Cancellation

If printing has been sent to the press an order cannot be cancelled. Please contact me immediately to discuss.

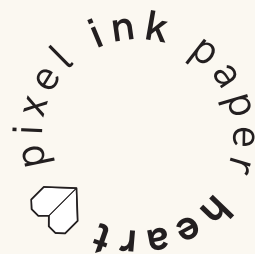

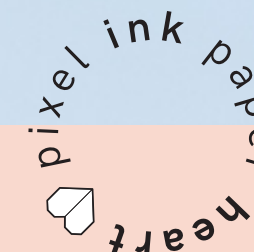
Refunds
